Wildwood Canyon

Campsite subdivisions on the environs of Los Angeles had to come. The mountains in the vicinity of any large city are dotted with the cottages of country loving folk, who have to live in the city to gain their livelihood but leave for the open for their holidays.

And Newhall is the most logical place for such a community. Its proximity to Los Angeles, combined with its great natural beauty, and the even greater beauty of its draws and canyons, choked with trees, are such a magnet that even a county ordinance to the contrary couldn't hold such colonization back indefinitely.

Four years ago, Newhall people may recall that, at the time of the Newhall Improvement Association, the writer tried to impress upon the association the extreme desirability of attracting attention to Newhall by advertising and other necessary means to try to get our quota of the Los Angeles people that are establishing camps in various localities around the city.

No concerted attempt has yet been made to call attention to the rare beauty of our Newhall hills. The Chamber of Commerce has certainly done little in that respect. It has been left to private enterprise to start the campaign. It is slow work. So many of the motoring world recall Newhall as a way station on the highway with nothing to distinguish it from the ruck of the small California towns, that it is sometimes hard to convince them that such a slight detour will open up the beautiful hill country adjacent to the Happy Valley and the Pico road. They seem to think that if there were such beauty, they would have heard of it.

Pioneering in any new enterprise is costly. This first attempt to place Wildwood Canyon before the public is no exception. Before anything could be done in that regard, roads had to be constructed through rough canyons and expensive development, such as surveys, and the installation of utilities undertaken. Newhall has as yet no recreational facilities that would be attractive to the week-end pleasure seekers, and Wildwood Community facilities had to be provided by developers overcoming that weakness.

This current year is being widely wild-catted by irresponsible prices and terms. In fact, if the buying public were to figure their propositions out carefully, they would realize that the gross returns from such campaigns would not allow of the expensive attractions promised for some future date. Yet Wildwood Canyon has to compete with those

Establishes Gold Camp.

Concerning the bond proposition which is to be decided on June 27, there is only one thing to think of; but that one thing comprises a number of points very vital to the welfare of the community.

The needs of the school, and the demand for more room should settle the question with anyone realizing the importance of a good school in enhancing the desirability of a village such as ours as a place in which families can locate with assurance of good school facilities. The opposition will come from those who perhaps think the cost is too great, or that the present building can be enlarged to meet the need for room. The question

of the new building, we believe, can be safely left to the business judgment of the members of the board, and there is no doubt that their best efforts will be used to make every dollar go as far as possible. As to adding rooms, this has never proven a satisfactory way, unless the original building was designed with an addition in view, which certainly was not the case here.

Of course some are sure to vote against the bonds, regardless of everything. One of these must be matched by two who vote in the affirmative. For this reason every voter favoring a bigger and better school and building should not fail to turn out and

It's on June 27th.

It is too bad that helpless children had to give their lives to waken the people of Southern California to the fact that unsafe school buildings are being used. It will bring back none of the helpless young lives, however, to find fault with those who conducted the "School of Hope. The thing to do is to make sure by agitation, regulation, or enactment, if there are not laws governing such things, that it shall not happen again.

Now the quarantine on the hoof and mouth has been modified to include very little area, the veterinarians and authorities should see to it that such a knowledge of the disease is acquired at once that will enable them to control it by more scientific way than by using a rifle. The fact that it is contagious and infectious disease points the way for medical research. Let there be no delay in making a beginning, and enough progress in the work, so the next outbreak can be controlled by good veterinarians instead of poor butchers.

The republican national convention at Cleveland next week will have only the question of the vice-presidency to settle. President Coolidge has a clear field for first place.

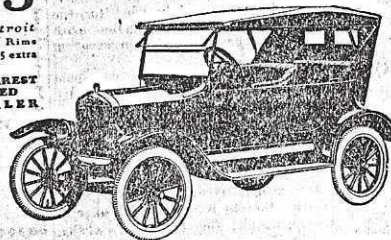

Treatment of Poison Oak

THE commonest form of plant
poisoning comes from the
poison ivy, commonly known
as poison oak.

The poison is due to a powerful non-
volatile oil that is most apt to enter
through the open skin pores when the
victim is perspiring. Many persons be-
lieve they are immune from oak poison-
ing but in reality immunity is very
rare.

No stock should be taken in any of
the so-called remedies for poison oak,

since the sad truth is that no remedy
exists. The disease is obliged to run
its course regardless.

The first thing to be done in case one
is aware of having been in contact with
poison oak is to attempt to wash off
the dangerous oil before it has an op-
portunity to penetrate under the sur-
face of the skin. This can best be done
by repeated washings with cheap laun-
dry soap. If the washing has been
thorough the chances are that poison-
ing will not set in.

After the skin eruptions are well de-
veloped, the main effort should be di-
rected toward preventing the spread of
the poison by means of the finger-nails.

Many secure almost immediate relief
by the simple method of bathing the
poisoned area in plenty of hot water.

Do not use sugar-of-lead upon the
open poison oak wounds, since there is
always danger of lead poisoning. Even
zinc oxide, another favorite "remedy,"
should not be used until the spread of
the disease has been checked and the
open sores have commenced to heal.

Someone has suggested that only
those who have fought a forest fire for
48 hours straight be permitted to
smoke in the mountains. Selah!

Such Stuff as Justice is Made Of

A MAN with a wife and two
little children—driven to it
by want—forged the name
of his employer to a check
for \$190 and was sentenced to prison
for four years.

A man carelessly tossed a cigarette
into a forest, causing a fire which did
damage to the extent of thousands of
dollars, and was fined \$5.

In the former case, the husband was
imprisoned for four years—the wife
was obliged to give up her home and
turn her children over to the Juvenile
Court, while she struggled for a mere
existence. For four years, these two
children—when they needed it most—
were deprived of the care of a mother
and a father. Then the man was giv-
en his "liberty" and branded for the
rest of his life as an "ex-convict" with
all its attendant obstacles in securing
employment.

In the latter case, the smoker paid
his \$5 fine and said he was sorry. He
went his way with no blemish on his
character and with no consciousness of
the ultimate damages wrought by his
criminal negligence: destruction of
timber—denuded hillsides, dried-up
watersheds; destroyed refuge of game,
floods—thereby robbing many of em-
ployment and the nation of wealth
which will take generations to restore.

Did the punishments fit the crime?

NOTICE OF SCHOOL BOND ELECTION.

Notice is hereby given to the qualified electors of Newhall School District of Los Angeles County, California, that, in accordance with the provisions of the Political Code of the State of California, an election shall be held on the 27th day of June, 1924, at the School House, in this School District, between the hours of 8 a. m. and 8 p. m. (during which period and between which hours the polls shall remain open), at which election the question of issuing and selling bonds of said District to the amount of Forty Thousand Dollars for the purpose of raising money for purchasing school lots, for building or purchasing one or more school buildings or making alterations or additions to any school building or buildings, for repairing, restoring or rebuilding any school building damaged, injured or destroyed by fire or other public calamity, for insuring school buildings, for supplying school buildings with furniture or necessary apparatus, for improving school grounds, shall be submitted to the qualified electors of said District and be voted upon.

The said bonds proposed to be issued and sold shall be of the denomination of One Thousand Dollars each and shall bear interest at the rate of 5 1/2 per cent per annum, payable semi-annually. Said bonds shall be numbered from 1 to 40 consecutively, payable as follows: Bonds numbered 1 and 2 to run 1 year, Bonds numbered 3 and 4 to run 2 years, Bonds numbered 5 and 6 to run 3 years, Bonds numbered 7 and 8 to run 4 years, Bonds numbered 9 and 10 to run 5 years, Bonds numbered 11 and 12 to run 6 years, Bonds numbered 13 and 14 to run 7 years, Bonds numbered 15 and 16 to run 8 years, Bonds numbered 17 and 18 to run 9 years, Bonds numbered 19 and 20 to run 10 years, Bonds numbered 21 and 22 to run 11 years, Bonds numbered 23 and 24 to run 12 years, Bonds numbered 25 and 26 to run 13 years, Bonds numbered 27 and 28 to run 14 years, Bonds numbered 29 and 30 to run 15 years, Bonds numbered 31 and 32 to run 16 years, Bonds numbered 33 and 34 to run 17 years, Bonds numbered 35 and 36 to run 18 years, Bonds numbered 37 and 38 to run 19 years, Bonds numbered 39 and 40 to run 20 years.

The following named persons, being competent and qualified electors of this School District, are hereby appointed officers of election to conduct said election, to-wit: A. G. Thibaudeau as Inspector, and Pearl B. Russell and Christine Woodard as Judges, and said Inspector and Judges shall make return of said election pursuant to law.

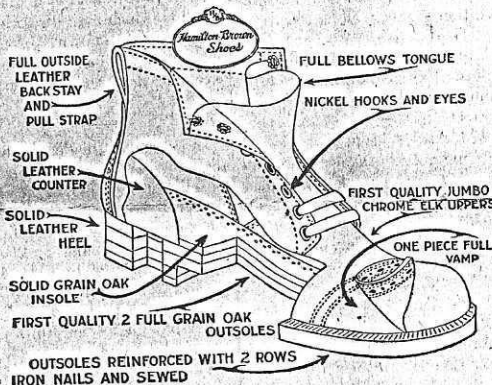

wildcats as well as with the legitimate campsites, of which there are many, and many of which are in mountains, or localities where there is concerted community and association effort to keep their advantages before the public.

For more accurate comparison, there are widely advertised campsite propositions within an hour's ride of here, where, for instance, the lots are 40x62, or smaller. The smallest lot in the Wildwood tract has 7500 square feet in it. The largest lot has three-fourths of an acre. The average lots are a fourth of an acre. By far the majority of advertised campsite subdivisions sell under grant deeds, or even leases, the first being no title protection, the second not even being a title. Such conditions are to be found on subdivisions based upon tax titles, clouded titles, and other devious ways of circumventing the real estate laws.

In comparison with such conditions, every lot in Wildwood Canyon carries individual Certificate of Title Insurance.

Many of the campsite subdivisions have no proper road facilities. You "pack" in to your lot over another's property. Every Wildwood Canyon lot faces on a forty-foot road and you can drive your car direct to any Wildwood lot.

Our city brother is an aesthetic plant, so Wildwood Canyon installs a pumping plant and puts the water mains in front of each lot—and to avoid future argument over water, the water plant is included in the community improvements decided to the lot owners. The Edison lines will be extended to Wildwood Canyon at the developers' expense, thus furnishing electricity for cooking and lighting.

For recreation, the Wildwood Canyon lot owner will have his Community House, situated in Community Park, and within a stone's throw of the swimming pool. These enterprises are not public, as they are owned by the lot owners in Wildwood and could be leased, loaned or otherwise utilized by the public at large only with the consent of all the lot owners.

The Community House is be-

ing equipped for dancing as well as rustic entertainment.

From the foregoing, some of the difficulties in promoting a Newhall campsite subdivision may be seen. Development is not a path of roses. Already a mile and a half of roads have been built by local men to open this tract and wherever possible all the development money has been, and is being expended in Newhall. On the other side, it has been most surprising and gratifying to see the individual responses from Newhall citizens to the enterprise. Newhall people were among the first to purchase property in Wildwood and at all times a wonderful spirit of co-operation has been shown. With Wildwood Canyon a success, within three years, the Newhall Assessment Roll will have doubled and reached the figure necessary before we can vote out of the Los Angeles High School District and build our own High School. Our assessment district will be so productive that the expense of municipal improvements, such as the curbing of the streets, may be undertaken and the town itself will be well on the road to incorporation—an act now most impractical because of our small size. Think of the difference to the assessment roll when acreage of \$8 to \$12 assessment becomes developed into improved lots at eight to twelve hundred valuation. Other developers (legitimate builders of the country it is devoutly to be hoped) will come

in and take over and develop our present waste land.

It's a hard, long, rough and expensive road, trying to attract attention to a district that had laid dormant for so many years as has this one. Co-operation and plugging will overcome the handicap. The developers of Wildwood Canyon appreciate the courtesies already offered them (as, for instance, the opening of the "Signal's" columns to this article), and do assure Newhall residents that their city friends, in the market for a cabin site, cannot do better than investigate Wildwood Canyon. Your friends will be pleased and our Newhall community will have made another stride towards their ultimate civic independence.
