## Fine Camp Ground

Those of our readers who are intending to go on a little camping trip not too far from home, the Live Oak Springs Cabin Site property will be of interest.

These grounds are located two miles above the Solamint Grocery and altho there is plenty of shade, it is an open space which eliminates the chances of fire. There is plenty of water for campers' use.

This place is owned by a company of Hollywood men and to date 400 to 500 cabin sites have been sold. People are encouraged to camp, but campers are not under any obligations to purchase sites.

There is a dancing floor and player piano for the use of those camping on the grounds. And Mr and Mrs Miller will serve hot dog, coffee and soft drinks.

As many places are now closed to campers because of fire hazard, this place will be a welcome haven.

## Telephone Service Extended

A telephone has been installed in McGinnis & Urfer's confectionery store, and it has been made a pay station, so anyone wishing to do so can put in a long-distance call until the store closes about 11 o'clock.

This will be appreciated by our people, for there has been considerable dissatisfaction because telephone service closes at 7 o'clock p. m. The new arrangement will permit of long distance calls being put in four hours longer.

If we keep on hoping, we will eventually get 24 hour service. All nite telephone service can be had at Wood's Garage at Saugus.

## Southern California Road Building

Southern California during the first six months of 1924 has contracted for more than five million dollars of road work, one-third of which has been state funds, and the remaining two-thirds provided by the counties. This year the state is building more than 350 miles of highway. There were 46 different projects undertaken.

In addition to this road work there were 13 bridges placed under construction, totalling nearly 1,200 feet in length and involving expenditures of more than \$124,000.

These figures are estimated from records of the engineering department of the Automobile Club of Southern California, which organization has always been a strong proponent of good roads, and which keeps tab of the highway construction through this section.

The state projects approximate \$1,750,000 in expenditures and include 11.9 miles of gravel road in Imperial County; 27.5 miles of cement and asphalt concrete and grading in Los Angeles County; 21.2 miles of grading and Portland cement concrete in Orange County; 24.6 miles of grading, cement concrete, widening and sea wall in Ventura County. In Orange County, also, the state is building a 522 foot bridge across the Santa Ana River.

County highway construction shows 40 1/2 miles of asphalt concrete in Kern County; approximately 48 miles of road work in Los Angeles County of practically all classes; 13 miles of graveling, asphalt and cement concrete, and widening in Orange County; nearly six miles of macadam in Riverside County; 132 miles of repairing and macadam, and macadam and oil in San Bernardino County; five miles of cement concrete in San Diego County; 25 miles in Santa Ynez Valley in Santa Barbara County; and three miles of asphalt macadam in Ventura County.

The politicians seem to be very greatly worried over La Follette. Well, if he should be elected, and have half of the honesty he professes, he might make a good president, at that. And he has never been accused of dishonesty.

To the average observer the chances seem to be all an favor of the re-election of President Coolidge. The New York convention seemed smooth enough at the close but there has not been as dissatisfied a bunch of politicians in twenty years as came from that convention. And while the third party

vote may be heavy, it will hardly change results.

Secretary of the Treasury Mellon has accomplished one great thing that will be remembered to his credit long after his enemies are forgotten. He reduced the public debt \$5,000,000,000. This means an annual saving of more than two hundred million dollars. This is absolutely the best and most useful government financial transaction in all history.

Arkansas was the first state to ratify the Child Labor Amendment to the United States constitution, and Georgia was the first state to reject it. It takes affirmative action by the legislatures of thirty-six states to make it a part of the constitution. The courts have held that the states have no power under the constitution to prevent child labor when the children are employed in one state in a factory owned and operated by citizens of another state. Under the proposed amendment child labor will be at once made unlawful in many of the states.

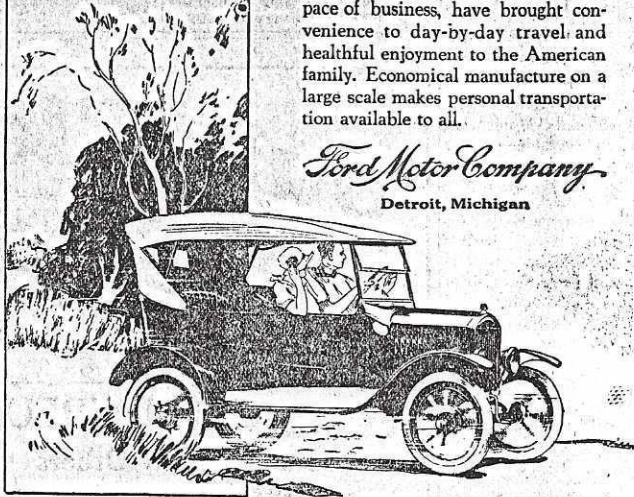

### THE RADIUM SPRINGS FIRE

SO much bunk and mis-information appeared in the daily press during the nine days of the Radium Springs fire, that it discourages an honest discourse of the subject. Suffice to say that the fire was never closer than six miles to any part of the Ridge. The area burned over was about forty square miles. Never was there more than one hundred men on the line at one time. Back-firing was resorted to by forest officers three times. The Hughes Lake or Elizabeth Lake resorts were never in serious danger. Three houses were burned to the ground. Lower Elizabeth Lake Canyon from Radium Springs to Johnson's ranch, a distance of nine miles, was literally swept clean of timber and brush. Aside from this spectacular run, the fire ate up most of the vegetation of every kind, including much valuable timber, in Pine and Shake canyons, also in a portion of Fish Creek canyon. One side of Sawmill Mt. and one side of Burnt Peak were burned over. The flames climbed to the highest elevation at the summit of Burnt Peak. The fire started at about 5 o'clock, Wednesday evening, July 9th, and was not brought under control until late in the evening of July 19th.

Culver City offers unusual inducements to all the "live wires" of National Forest Inn. We don't know what kind of apples they raise at Culver City, or who raises 'em, but we do know that when these said apples are concentrated under pressure, they certainly "do their stuff." As a result of a recent pilgrimage of the "live ones" to the domicile of one Mr and Mrs Tom Rose, in said Culver City, National Forest Inn has just been introduced to a number of new fox trot "cider steps" that defy imitation. Oh, Oh! "It won't be long!"

On account of the extreme fire hazard this season, camp-fire permits for the Ridge Route division will be issued for the following locations only: National Forest Inn, Airo Ser

vice Station, Tumble Inn, Kelly's and Sandberg's. No camp-fires will be allowed along the highway between Martin's and Sandberg's except at the places named.

The thoughtfulness, hospitality and general co-operation of Mr. Austin of the Hughes Lake resort during the trying days of the recent Radium Springs fire, is greatly appreciated by the boys in the Forest Service. Each day a number of the boys were treated to bathing suits and a free swim in the lake. Mr. Austin was also right on the job in helping out in the matter of actual fire suppression. He and his men did some highly effective work on the line.

The following National Forest officers were in charge of suppression forces on the recent Radium Springs fire: Wm. Mendenhall, Deputy Supervisor, Santa Barbara; N. E. Peterson, District Ranger, Newhall; Ranger Valentine, Ojai; Guard Freeman, Ojai; Guard Ziegler, Newhall; Ranger Robinson, San Francisco, and Guard Doelle, of National Forest Inn. County Forest officers: Turner, Thurston and Graves. The unhesitating and generous co-operation of Assistant Forester Thurston in the hours of greatest need, is especially appreciated by the Service.

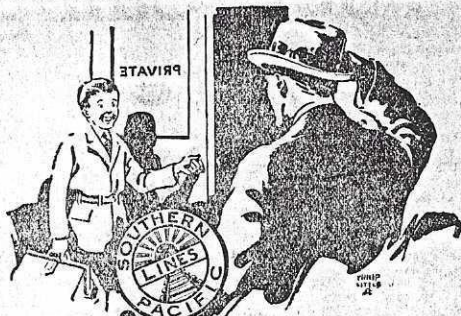
