MUST SMOKE AT HOME ONLY

Supervisor Pass Ordinance In Interest of Fire Control

By the terms of an ordinance now in force considerable restriction is placed on smoking the supervisors desiring to eliminate as much of the fire hazard as possible. The ordinance ends December 1, unless sooner repealed. The provisions of the ordinance are as follows:

Section 1. Declares an emergency.

Section 2. It shall be unlawful during the period of this emergency hereinabove declared, for any person to shoot, fire or discharge any rifle, shotgun, pistol or other firearm upon or onto, or to smoke tobacco or other substance, in any forest land or land covered with brush, grass, or other inflammable material in the county of Los Angeles outside of incorporated cities except as provided in Section 3 hereof.

Section 3. This ordinance shall not apply to the owner of property while on his own land, nor shall it apply to the discharge of firearms by peace officers in the performance of their duties.

Section 4. It shall be the duty of the County Fire Warden to enforce the provisions of this ordinance.

Section 5. Any person violating the provisions of this ordinance shall be guilty of a misdemeanor, and upon conviction thereof shall be punished by a fine of not over five hundred dollars, or by imprisonment in the County Jail for not over six months, or by both such fine and imprisonment.

Section 6. This ordinance shall take effect immediately upon the passage hereof, because the adoption and enforcement hereof is necessary for the immediate preservation of the public peace, health and safety by reason of the fact that the public peace, health and safety is menaced by the dryness and inflammable condition of the vegetation of the County of Los Angeles. It shall remain in effect until December 1st, 1924, unless the board shall sooner declare that the emergency and the menace to the public peace, health and safety shall have ceased to exist.

Auto Sense

Although greater efforts than ever before are being made to protest motorists and pedestrians alike on the highways, there are still a large number of unnecessary traffic accidents. Many rules have been suggested, and the public safety department of the Automobile Club of Southern California believes that observance of the old-fashioned "golden rule" will go a long ways toward making the highways safe.

From the many suggestions for safe driving, the following are regarded as so important that they have been called the ten commandments of driving. They are:

1. Drive on the right side of the road; it's just as good as the left.
2. Slow down when approaching a cross road; it is nearly as dangerous as a railroad crossing.
3. Look out for children. You never can tell what they will do, and you are always in the wrong if you hit one.

4. Try to help instead of hinder the traffic officer; he is there for your good and he's got a tough job.
5. Be sure that your "dimmers" really dim; it's no joke driving into a blinding glare, as you probably know.

6. Read and obey the warning signs; they are not put up as ornaments.
7. If you feel you've got to speed, do it where it won't kill anybody but yourself.

8. When making minor repairs, stop where your car may be seen from both directions; otherwise you may stop longer than you anticipate.

9. Speeding around corners is a straight route to the hospital. Don't race past a stopped street car. Some day the jury may call it manslaughter.

10. Use discretion. The fact that you had the right of way don't bring anybody back to life, least of all yourself.

DRIVING the ridge between Castaic and Sandberg's with only one light or with no lights at all is getting to be quite a popular outdoor sport. It is a menace that should be abated. We don't see any reason why the Ridge, one of the most dangerous roads in the county, should be neglected. It is safe to say that an average of 50 machines a night pass the National Forest Inn, carrying but one light. Other laws, such as speeding on curves and passing cars on blind curves, are carelessly disobeyed on many occasions. The people are paying for police protection on the highways and we think it's about time they were getting it, at night as well as during the day. Two motor cops, working north and south from Sandberg's do very effective work in the territory they patrol during the day. But they are not permanently stationed at Sandberg's, altho they should be. In addition, the Ridge needs cops at night, stationed either at the Inn or at Sandberg's. People who drive the Ridge, under the law would, we are sure, appreciate some action on this proposition by Captain Cannon, of the Sheriff's office.

A new addition to the National Forest Inn menagerie is Hop Lee, a Pekinese pup and brother to Pollyanna. Hop Lee is the property of Mr. and Mrs. Will Rose. It's a cinch that folks down in Culver City know how to do two things well, namely, raise Pekinese pups and make apple cider.

Guard Vaughn is now stationed at the Liebre camp of the Pan-American Oil company. Mr. Vaughn is a very capable forest fireman and his presence at Liebre means a more adequate protecting service for the Ridge. The camp at Liebre now numbers over a hundred men and is increasing in size every day. It is understood that the Pan-American will convert the present Red Rock trail, leading from the Ridge to Castaic canyon, into a standard gauge wagon road. This will be much appreciated by forest men in this district.

The Theft Bureau of the Auto Club of Souther California, lists on an average of seven stolen cars a day. Many more cars are stolen which are not listed by the Club. Auto stealing seems to be lucrative pastime in California. A great many stolen cars are eventually recovered by various police officers and the thieves prose-

cuted. However, there are also many cars that are never located following their disappearance.

The Forest Service has been extremely lenient with thoughtless and careless offenders of the law during the past few years. We think that any man who throws a lighted match, cigar or cigarette out of his car along the highway, should be arrested and fined. We also think that any one who builds a campfire inside a National Forest without a campfire permit, should be arrested and prosecuted. Everybody may rest assured that if the Forest Service does tighten up on these two classes of "mountain pests," that the tightening will be very severe.

Advertising signs of every description are prohibited inside the limits of any National Forest. (Politicians and tobacco manufacturers, please take notice). Fifty-three signs were recently removed from the Ridge Road division and destroyed.

Would Solve Power Trouble?

Since the opening of the conservation campaign in charge of Power Supervisor H. G. Butler, one mystery has deepened with the passing days. Where was Rainmaker Hatfield with his wizard chemicals that he says never—or almost never—fail to coax from an inscrutable Providence what the prayers of the most devout seem unable to do?

Hatfield for some strange reason, still withholds his benison, but a rival with all the confidence of the more famous sky magician has indicated in a letter to Mr. Butler that the rationing of "juice" need last only so long as it takes for the magician to get on the job.

The letter is from W. H. Elliget, a business man of high standing in Corcoran, California, who is speaking for the rainmaker. The latter is remaining modestly in the background for the present. Says his sponsor:

"This party knows more about weather and the action of the moisture arrangement than all the U. S. weather observers combined.

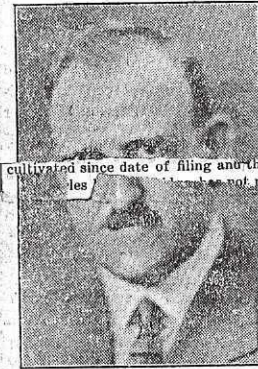

California Highway

That California will have to maintain full speed ahead on its highway program is indicated by the biennial traffic census taken in June. This indicates an increase of approximately 47 per cent over the figures for 1922, the date of the last census. Curiously enough this is equal to the increase that was recorded for the period between 1920 and 1922 and shows that the traffic expansion is keeping pace with the growth in the number of motor vehicles.

The result of the two biennial checks on traffic in all parts of the state appear to indicate that there has been a constant annual increase in the use of the roads since 1920. If the future is to be judged by the past, similar growth will be recorded in 1926, making it imperative that every possible activity be employed in maintaining existing highways, widening those that are overburdened with traffic, and providing new roads to relieve the more congested sections.

It is pointed out by authorities on highway construction that the process is a continuous job, as old roads are constantly in need of repairs and the rapid increase in vehicles using the roads makes pressing need for additional outlays.

The Automobile Club of Southern California, the State Highway Commission and various boards of supervisors after thorough investigation are agreed with the special committee appointed by the governor that new methods of financing highway construction must be adopted. It is generally conceded that plans must be devised that will be equitable and furnish a steady and ample source of

revenue to provide for a systematic and adequate highway development program.

Got Bullet in Chest but Saved His Friend

A duel was fought in a forest on the outskirts of Berlin recently between two men more than forty years old who had been lifelong friends, according to a Berlin letter in the Continental edition of the London Mail.

They are both bachelors, but one, a merry squire, fell in love with a pretty girl of twenty-one and was determined to marry her. The other, a wealthy business man, was certain the pretty girl would make his friend unhappy. He noticed, for instance, that when the three of them were in restaurants the pretty girl returned the adoring glances of young men at other tables.
